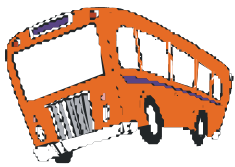

## RRDSSAB Housing News



### Affordable Housing Program – Home Repair

The Rainy River District Social Services Administration Board (RRDSSAB) is pleased to announce that we have entered into a partnership with the Federal Government and the Province of Ontario to deliver the Northern Homeowner Repair Program, a component of the Canada-Ontario New Affordable Housing Program (AHP). The Program will assist homeowner households with affordability and housing problems so they may continue to live in their homes. The program provides financial assistance to repair or rehabilitate dwellings to a minimum level of health and safety, including features that increase accessibility and address mobility concerns. Eligible repairs fall under the following categories: structural, electrical, plumbing, heating, fire safety, septic systems, well water and safety-related features that support seniors ability to age-in-place. The MNO is delivering this program on behalf of the RRDSSAB.

### Affordable Housing Program - Energy Efficiency Program

On February 23, 2007, the Provincial Government announced the Affordable Housing Program – Energy Efficiency Program (EEP), a joint initiative of the Ministry of Municipal Affairs & Housing (MMAH), the Ontario Power Authority (OPA) and Natural Resources Canada (NRCan). Rebates will be offered under the Program to encourage the purchase and installation of energy efficient products. The EEP will be available to applicants participating in the AHP-Home Repair Program.

The MMAH-OPA-NRCan Energy Efficiency Program, Phase One, will offer up to \$850 per unit to help offset the incremental cost of purchasing ENERGY STAR® qualified products. An education and awareness program will be delivered to affordable housing stakeholders through the RRDSSAB to raise awareness of energy efficiency and energy-efficient product choices.

If you are applying for the Home Repair Program, you may also apply for the Energy Efficiency Program.

## Non-Profit Housing News

To build on the success of the Municipal delivery of housing for low income households, the *Ministry of Municipal Affairs and Housing* has allocated a one-time capital grant of \$350,00 to assist the RRDSSAB under a program, *Delivering Opportunities for Ontario Renters (DOOR)*. The DOOR funding comes with a high degree of flexibility, as it is unconditional. A total of \$152,666.67 will be distributed between our 10 Non Profit Housing Providers with the remainder being utilized by our DSSAB Housing DOOR Program.

The RRDSSAB is responsible to ensure Housing Programs are administered according the relevant legislation and regulations. These *Non Profit Housing Provider* are: Flinders Non Profit, Atikokan Crisis Centre, Fort Frances Native Urban Housing, Rivercrest Terrace (Atikokan), Golden Age Manor (Emo), Morely Municipal Housing, Fort Frances Municipal Non Profit Housing, Faith Non Profit, Atikokan Native Non Profit Homes Corporation and Columbus Place.

## Ontario Works Update

The 2007 Provincial Budget announced changes that will affect Ontario Works. The changes include:

- 2% social assistance rate increase (December 2007);
- A new Ontario Child Benefit (OCB); and
- Federal Working Income Tax Benefit (WITB) for social assistance recipients.

The 2% increase for Social Assistance Rates will be paid effective December 1, 2007.

The Ontario Child Benefit is targeted to families with children under eighteen (18) years of age and will be phased in over a five (5) year period. The benefit will commence with a one-time payment of up to \$250 per child in July, 2007.

The Federal Government has provided for a *Working Income Tax Benefit* which is a refundable tax credit of 20% of each dollar above \$3,000 of earned income to a maximum credit of \$500 for a single person and \$1,000 for a family.
