## Service Delivery Review Released

The results of the Provincial Municipal Fiscal and Service Delivery Review (PMFSDR) have been released. The report emphasizes the centrality of integrated service planning, local flexibility and streamlined service delivery and affirms the successful role of municipalities and district as manager of human services. Included in the report is the upload of all Ontario Works (OW) benefit costs by 2018, the consolidation of all housing and homelessness programs into a municipal housing service, and a commitment to human service plans that better integrate policy, funding and accountability frameworks in the areas of social assistance, homelessness, child care and housing.

At present, the RRDSSAB funds 20% of the Ontario Works benefit costs. Ontario will upload the cost of Ontario Works benefits, beginning in 2010 along the following timetable:

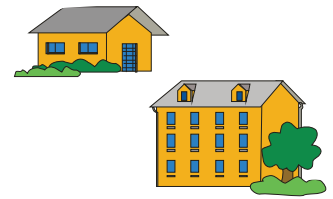
As of today, the arrangement for 50/50 for Ontario Works administrative costs stands, based on 2009 approved allocation. The Report Highlights include:

- A commitment to work in a timely fashion to simplify and modernize delivery of income assistance and employment-related supports and to better integrate Ontario Works, Ontario Disability Support Program (ODSP), and Employment Ontario services to improve outcomes for clients and to make better use of resources.
- The consolidation of all existing housing and homelessness programs into a housing service managed at the municipal level.
- Enhancing the capacity of municipalities by coordinating community-based local service delivery and building on multi-year housing plans.
- Harmonizing policy program areas at the provincial level which will take place as a key element of the province’s Long-Term Affordable Housing Strategy.
- Provincial and municipal collaboration to introduce a shared accountability framework for cost-shared programs that focuses on the outcomes of the people actually being served by those programs.
- An introduction of a new community human service plan encompassing a range of social services including social assistance, homelessness, child care and housing.

Today’s report also mentions the Ontario Municipal Partnership Fund (OMPF) stating that OMPF will remain responsive to changes in municipal circumstances, such as the upload of the Ontario Drug Benefits, ODSP, and OW benefits. Consistent with the normal operation of the OMPF, the social program grants will be adjusted to reflect the reduction in municipal costs for these programs as the uploads are phased in. As a result, the OMPF will decline to a level of about \$500 million by 2016.

## Housing Update

We are seeking all low income households in the Rainy River District needing repairs to their principal residence.



Interested homeowners should apply to take advantage of the Northern component of the Canada-Ontario Affordable Housing Program (AHP). Qualifying homeowners will receive funding from RRDSSAB to undertake repairs of modest and affordable ownership housing.

The Northern component of the AHP aims to maintain the affordable housing stock in northern Ontario.

The social assistance rate increase of 2% announced in the March 2008 budget will be implemented effective December 1, 2008 for Ontario Works.

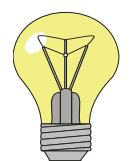
