## Best Start: Helping Young Children Get the Best Start in Life



We want the best for Ontario's babies and children; that means making sure they get the best possible start in life.

In order to achieve this, the Ministry of Children & Youth Services has launched the Best Start Initiative. It's a Plan to strengthen healthy development, early learning and Child Care services, during a child's first years. We want children in Ontario to be ready and eager to

excel in school, by the time they start Grade 1.

Best Start is a bold strategy - one that will involve a massive expansion of quality and affordable Child Care and investments in children's healthy early development - all in a convenient and easily accessible location for parents. Approximately \$1.1 billion in new Federal funding over the next three years, beginning in 2005-2006, will enable us to work with our community partners, including School Boards, Public Health Units, Child Care and Children's Services Providers, and Municipalities - to make sure that:

- all children and parents have access to services and supports, regardless of individual economic or social circumstances;
- pre-school, Junior Kindergarten, Senior Kindergarten, quality Child Care, Public Health, and Parenting Programs are integrated into a seamless system that supports families and children;
- early and on-going screening of Ontario's children to identify potential issues, needs and risks is strengthened; and

Congratulations also to Riverside Paramedic Jennifer (Bodnar) Olson and Christopher Olson on their recent marriage. We wish them health and happiness for the future.

Recent funding announcements from the Province for Land Ambulance continue to fall short of the requirements for the Rainy River District. Only \$24,422 was announced by the Province for increases on Paramedic Wages and Benefits with an additional \$135,710 for adjustments to Townships Without Municipal Organization (TWOMO). Further TWOMO adjustments may be forthcoming, however, the amount and effect remains to be evaluated. The Province continues to fail to recognize their fair share of the increases in Paramedic Wages and Benefits, since transition of the Land Ambulance Program. Additionally, NO funding was received to offset increased operational costs related to fuel for vehicles, utilities, procurement of supplies and equipment, or administration costs. The Province continues to increase the burden to our Municipal Taxpayers, while failing to step up to the plate and pay their fair share.

The RRDSSAB continues to lobby the Province for adequate funding. Discussions on First Nations funding, administrative funding and proposed legislation changes on paramedic qualifications are ongoing. The RRDSSAB continues to seek a resolution on these and many other issues to minimize the impact to the Rainy River District.

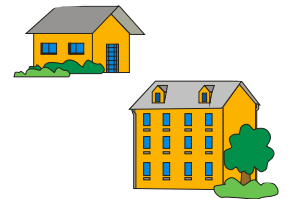

## Social Housing Update

The Federal and Provincial Governments have signed a joint Affordable Housing Program to build 20,000 new affordable housing units in Ontario. The Programs includes funding for new housing units and housing allowances. For northern District Social Services Administration Boards, the Program includes a Remote Program component that may provide opportunities for social housing in the Rainy River District. Unfortunately, much of the program's funding is geared towards larger urban areas with long waits lists. Until the details and design of the Remote Program is released to the RRDSSAB, it is not known if, or to what degree, the RRDSSAB will participate. Our concern is the possibility that there will not be sufficient administrative funding to effectively administer the Program. It is hoped that the Remote Program will provide funding that enables supportive housing to be developed, as well as funding to renovate existing social housing stock in the District. More details will be provided by the Ministry of Municipal Affairs & Housing in November, 2005.

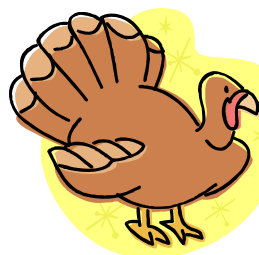
